### **CHG Healthcare Expands, Relocates to Millrock Park in Holladay Cites Importance of Building Location, Accessibility, Efficiency and Design in Accommodating Company's Growth**

SALT LAKE CITY (December 13, 2005)—CHG Healthcare Services, Inc., one of the largest providers of healthcare staffing services in the United States, today announced plans to move its corporate headquarters and Salt Lake operating divisions to Millrock Park in Holladay, Utah.

Company president and CEO, Michael Weinholtz, said the decision to move was based on the company's growth. CHG Healthcare (formerly known as CompHealth Group) has reached capacity in its current 87,440-square-foot of office space, which is spread between two towers in the Woodlands business park on 40<sup>th</sup> South and 7<sup>th</sup> East.

When the company's current lease expires in spring 2007, it will move to Millrock Park, a brand new development in Holladay, just off I-215 at the 6200 South exit. The 490,000-square-foot, master-planned business campus is located on 22 acres in one of the most desired locations in the Salt Lake Valley. The *Deseret Morning News* has touted Millrock Park "the area's hottest office space" because of its stunning views and east bench exclusivity.

Weinholtz cited Millrock's superior location, accessibility and quality as core considerations in the proposed move. "The developers are constructing the building to fit the needs of our growing organization. It will be class A+ office space with state-of-the-art construction techniques, materials and technologies, designed especially for us," he said. "We will initially occupy up to 117,000 square feet. However, our aim is to eventually take all 155,000 square feet of the building, so it also accommodates our future growth plans."

CHG Healthcare currently employs more than 450 people at its Salt Lake City headquarters and more than 1,000 people in its nine U.S. locations. The company has been a part of the Salt Lake City business community for 26 years.
